
# **Elder Abuse:**

#### LAURA TAMBLYN-WATTS, LLB

Laura is a Senior Fellow at the Canadian Centre for Elder Law and formerly served as its National Director. She co-chairs the Law and Aging team of the National Initiative for the Care of the Elderly, as well as co-facilitating the World Study Group on Elder Law. Laura also is a past chair of the Consumer and Investor Advisory Council established by the Ombudsman for Banking Services and Investments. Laura currently teaches at the University of Toronto where she is obtaining her doctorate jointly from the Faculty of Law and the Institute for Lifecourse and Aging.

#### **DEB BRYSON, PSYCHOGERIATRIC RESOURCE CONSULTANT**

Deb Bryson is a Psychogeriatric Resource Consultant (PRC) with the Alzheimer Society of Hamilton and Halton. The PRC role is funded by the Ontario Ministry of Health & LTC, and provides case consultation and education to formal care providers of persons who exhibit responsive behaviours associated with Alzheimer's Disease or other dementias.

#### KEYNOTE: WRESTLING WITH SEXUAL CONSENT IN THE WORLD OF DEMENTIA

Sexual consent discussions have long been the purview of teens and young women. But with the marked rise of persons with dementia, sexual consent discussions now need to move down the Life Course. How do we reconcile a 'no means no' youth nightclub narrative with the complex realities of seniors with fluctuating capacity in long-term care settings? This session will explore the edges of legal consent, including the evolving state of the law, regulatory and legislative requirements, and the real-life realities of sexuality of older adults.

#### WORKING WITH AT-RISK AND ABUSED OLDER ADULTS

This session is intended to be a guide for service providers and caregivers to help prevent and respond to abuse in older adults. Participants will be introduced to the definitions and warning signs of abuse in older adults, gain tools to better support effective communication, better understand mandatory reporting obligations, and be provided with provincial resources that can help with suspected cases of elder abuse.

#### **CASE SCENARIOS**

In this part of the program participants will work in small groups to consider case scenarios that will help them to identify the warning signs and types of elder abuse, navigate the decision tree (by assessing the nature of the abuse and working with the older adult to access resources) and identify strategies and resources to support at risk and abused older adults.
